Re: Amended Notice of Data Breach

To the Office of the New Hampshire Attorney General:

We are writing on behalf of our client, Liberty Mutual Group, Inc., to provide an update to our notice to the Office of the New Hampshire Attorney General dated March 31, 2021.

In our initial notice, we described a pattern of activity in our initial notice relating to unusual quoting activity on two of Liberty Mutual's auto quoting websites, which occurred on January 21, 2021 on GetCertainly.com and between November 21, 2020 and January 22, 2021 on LibertyMutual.com.

As the investigation into the quoting attack was ongoing, on March 11, 2021, Liberty Mutual discovered another unusual pattern of account creation activity on its website, LibertyMutual.com. As part of this activity, unauthorized third parties again received quotes using an individual's name, date of birth, and other personal information they had already obtained from another, unknown source. The unauthorized third parties then took additional steps to purchase an automobile insurance policy in the individual's name and create an online account for that policy. The unauthorized third parties may have accessed additional personal information for the individual through the account, including the individual's driver's license number. This pattern of activity occurred between March 6 and March 12, 2021. Liberty Mutual subsequently identified that this activity affected residents in your state.


As soon as Liberty Mutual discovered this March activity, it immediately took action to prevent any further unauthorized activity, including masking driver's license numbers in online accounts and disabling access to the online customer account for the unauthorized policies. Liberty Mutual is also canceling the unauthorized policies and working with authorities to prevent future unauthorized activity.

Liberty Mutual has now completed the address verification process described in our initial notice and has confirmed that a total of 78 New Hampshire residents were affected by the unauthorized activity and have been sent a notice between April 12 and April 26, 2021 by first class mail (see attached notification letters). Please note that the address verification process resulted in a lower number of affected New Hampshire residents than the number included in our initial notice.

We are writing to tell you that you could have been impacted by recent unauthorized access to your personal information.

What Happened?

We recently learned that an unauthorized third party used our public websites LibertyMutual.com and GetCertainly.com to submit fraudulent requests for auto insurance using names, addresses and/or dates of birth obtained from another, unknown source. On January 21, 2021 and January 22, 2021, we discovered an unusual pattern of activity on GetCertainly.com and LibertyMutual.com in which an unauthorized third party may have misused our online auto insurance quote application to access your driver's license number. Upon learning of this activity, we took immediate steps to prevent access to this personal information and worked to identify the potentially affected individuals. This activity occurred between November 21, 2020 and January 22, 2021.

What Information Was Involved?

Based on our investigation, it appears your driver's license number may have been exposed during this incident.

What We Are Doing?

As soon as we discovered this suspicious activity, we immediately removed the ability to view driver's license numbers during an online quote. We have reported this incident to the authorities and are assisting their investigation to prevent future fraudulent activity.

We are offering you «months_of_service» months of complimentary credit monitoring and identity theft protection services through Cyberscout, a company specializing in fraud assistance and remediation services. To activate these services, please follow the instructions included the attached *Additional Important Information*. We cannot enroll in the services for you, but are here to help if you have any questions.

You have a right to bring a civil action against a consumer reporting agency that violates your rights under the Fair Credit Reporting and Identity Security Act.
