Re: Incident Notification

Dear Attorney General Foster:

I am writing on behalf of our client, LifeBridge Health. On March 18, 2018, LifeBridge Health discovered malware infected the server that host LifeBridge Health's patient registration and billing system, and LifeBridge Potomac Professionals' electronic medical record. LifeBridge immediately began an investigation and engaged a national forensic firm. LifeBridge's investigation determined that an unauthorized person accessed the server through LifeBridge Potomac Professionals. The information potentially accessed may include patients' names, dates of birth, insurance information, diagnoses, medications, and clinical and treatment information, and in some instances, social security numbers.

Beginning today, May 15, 2018, LifeBridge Health is sending letters to approximately 38 New Hampshire residents pursuant to the requirements of the Health Insurance and Portability Act ("HIPAA"), 45 C.F.R. §§164.400-414 and N.H. Rev. Stat. Ann. § 359-C:20 in substantially the same form as the letter attached hereto.¹

LifeBridge Health has also established a dedicated call center that potentially affected patients may contact with questions. To help prevent something like this from happening in the future, LifeBridge Health has enhanced the complexity of its password requirements and security of its system.

Our investigation determined that an unauthorized person accessed the servers through one of our physician practices on September 27, 2016. Because you are a patient of a LifeBridge Health provider, some of your demographic information may have been included in the patient registration and billing system that all LifeBridge Health providers use. The information potentially accessed may include your name, address, date of birth, insurance information, and social security number.

At this time, we have no reason to believe that your information has been misused in any way. However, as a precaution, we are offering a free one-year membership of Experian's® IdentityWorksSM Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on immediate identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you and enrolling in this program will not hurt your credit score. - Access to your file is limited. And you must give your consent for reports to be provided to employers.
- You may limit "prescreened" offers of credit and insurance you get based on information in your credit report.
- You may seek damages from violators.
- Identity theft victims and active duty military personnel have additional rights.
