RE: Security Incident Notification

To Whom It May Concern:

I serve as counsel for MailMyPrescriptions.com Pharmacy Corporation ("MailMyPrescriptions.com"), and provide this notification to you of a recent data security incident suffered by MailMyPrescriptions.com. MailMyPrescriptions.com is a Covered Entity and is providing notification subject to the Health Insurance Portability and Accountability Act ("HIPAA") as well as applicable state law. On or around November 24, 2020, MailMyPrescriptions.com became aware of a potential compromise to one (1) of its email accounts. Upon discovery, MailMyPrescriptions.com immediately took steps to secure the affected account, which included resetting the password and implementing additional email and network security measures. Further, MailMyPrescriptions.com promptly began investigating the incident, which included engaging a third-party expert forensics firm. It was ultimately determined, on January 15, 2021, that one (1) email account experienced unauthorized access.

Upon confirmation of the unauthorized access to the MailMyPrescriptions.com employee email account, MailMyPrescriptions.com's third-party forensic experts immediately investigated whether the affected email account contained individuals' sensitive information. On February 17, 2021, after thorough investigation, MailMyPrescriptions.com learned that the unauthorized access may have allowed access to individuals' personal information. Based on these findings, MailMyPrescriptions.com learned that the potentially impacted data included information relating to one hundred and sixty-five (165) residents of New Hampshire. This information includes individuals' name, contact information, treatment/prescription information, health insurance information, and/or provider information. MailMyPrescriptions.com immediately worked to obtain sufficient address information to provide individuals with notification. On February 24, 2021, MailMyPrescriptions.com identified address information for affected individuals.

MailMyPrescriptions.com will be promptly notifying the affected individuals on April 8, 2021. MailMyPrescriptions.com is taking steps to comply with all applicable notification obligations.

NOTICE OF DATA BREACH

Dear <<Name 1>>:

I am writing to inform you of a data security incident experienced by MailMyPrescriptions.com that may have involved your personal information described below.

MailMyPrescriptions.com takes the privacy and security of all information very seriously. While we have no evidence to suggest that any of the impacted information was viewed or misused during this incident, it is crucial that we be as supportive and transparent as possible. That is why I am writing to inform you of this incident, to offer information about steps that can be taken to help protect your information, and to let you know about complimentary credit monitoring services that we are offering you through Equifax, one of the three nationwide credit reporting companies. I sincerely apologize for any concern that this incident may cause you. Let me reassure you that MailMyPrescriptions.com is fully committed to supporting you.

What Happened:

On January 15, 2021, MailMyPrescriptions.com learned that an employee email account experienced unauthorized access between February 3, 2020 and November 24, 2020. Upon confirmation of the unauthorized access to the MailMyPrescriptions.com employee email account, we immediately investigated whether the affected email account contained individuals' sensitive information. On February 17, 2021, we learned that the unauthorized access may have enabled access to your personal information. We immediately began working to obtain sufficient contact information to provide you with this notification.

While we have no reason to believe that any information within the affected email account was actually viewed, collected or misused during this incident, we are providing this notification to you out of an abundance of caution and so that you may diligently monitor your personal information and resources. We take great care in the security of our technology systems, and regret that this incident has occurred.

What Information Was Involved:

It is important to note, as mentioned above, that there is no evidence to suggest that any personally identifiable information has been viewed or misused. The personal information that could have been viewed by the unauthorized individual(s) may have included your name, in combination with one or more of the following data elements: date of birth; provider name; prescription information; treatment/diagnosis information; and health insurance information.

What We Are Doing:

We have taken every step necessary to address the incident and are committed to fully protecting all of the information that you have entrusted to us. Upon learning of this incident, we immediately performed a password reset and took steps to enhance the security of all information. Additionally, we retained a third-party forensic firm to conduct a thorough investigation and are offering you complimentary credit monitoring and identity protection services.

Credit Monitoring:

As a safeguard, we have arranged for you to enroll, at no cost to you, in an online credit monitoring service (*Equifax[®] Credit Watch Gold*) for <<12/24>> months provided by Equifax[®], one of the three nationwide credit reporting companies. Due to privacy laws, we cannot register you directly. Additional information regarding how to enroll in the complimentary credit monitoring service is enclosed.

What You Can Do:

We recommend that you remain vigilant in regularly reviewing and monitoring all of your account statements and credit history to guard against any unauthorized transactions or activity. If you discover any suspicious or unusual activity on your accounts, please promptly contact your financial institution or company. We have provided additional information below, which contains more information about steps you can take to protect yourself against fraud and identity theft.

- Credit monitoring with email notifications of key changes to your Equifax credit report

 - **Create Account:** Enter your email address, create a password, and accept the terms of use.
 - **Verify Identity:** To enroll in your product, we will ask you to complete our identity verification process.
 - **Checkout:** Upon successful verification of your identity, you will see the Checkout Page.
 - Click 'Sign Me Up' to finish enrolling.
- To sign up for US Mail delivery, dial 1-855-833-9162 for access to the Equifax Credit Watch automated enrollment process. Note that all credit reports and alerts will be sent to you via US Mail only. You will be asked to enter your Activation Code home telephone number, home address, name, date of birth and Social Security Number. You will be asked to provide Equifax with your permission to access your Equifax credit file and to monitor your file. Without your agreement, Equifax cannot process your enrollment. Equifax will provide a confirmation number with an explanation that you will receive your Fulfillment Kit via the US Mail (when Equifax is able to verify your identity) or a Customer Care letter with further instructions (if your identity can not be verified using the information provided). Please allow up to 10 business days to receive this information.

You can sign up for the online or offline credit monitoring service anytime between now and <<Activation Deadline>>. Due to privacy laws, we cannot register you directly. Enrolling in this service will not affect your credit score. You must be over age 18 with a credit file activate these services.

Monitor Your Accounts

We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your credit reports/account statements and explanation of benefits forms for suspicious activity and to detect errors. Under U.S. law, you are entitled to one free credit report annually from each of the three major credit reporting bureaus, TransUnion, Experian, and Equifax. To order your free credit report, visit www.annualcreditreport.com or call 1-877-322-8228. Once you receive your credit report, review it for discrepancies and identify any accounts you did not open or inquiries from creditors that you did not authorize. If you have questions or notice incorrect information, contact the credit reporting bureau.

¹ WebScan searches for your Social Security Number, up to 5 passport numbers, up to 6 bank account numbers, up to 6 credit/debit card numbers, up to 6 email addresses, and up to 10 medical ID numbers. WebScan searches thousands of Internet sites where consumers' personal information is suspected of being bought and sold, and regularly adds new sites to the list of those it searches. You have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any of the three credit reporting bureaus listed below.

As an alternative to a fraud alert, you have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without your express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., III, etc.);
2. Social Security number;
3. Date of birth;
4. Address for the prior two to five years;
5. Proof of current address, such as a current utility or telephone bill;
6. A legible photocopy of a government-issued identification card (e.g., state driver’s license or identification card); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft, if you are a victim of identity theft.

Additional Information

You can further educate yourself regarding identity theft, fraud alerts, credit freezes, and the steps you can take to protect your personal information by contacting the credit reporting bureaus, the Federal Trade Commission (FTC), or your state Attorney General. You have the right to file a police report if you ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, you will likely need to provide some proof that you have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement, your state Attorney General, and the FTC. This notice has not been delayed by law enforcement. Under Massachusetts law, you have the right to obtain any police report filed in regard to this incident.
