***RE: Security Incident Notification***

To Whom It May Concern:

I serve as counsel for Martin Energy Group Services, LLC. ("Martin"), and provide this notification to you of a recent data security incident. On or about January 25, 2021, Martin fell victim to a phishing attack as a phishing email containing a malicious link was sent to several Martin employees. Upon discovery, Martin performed a password reset for the affected accounts and swiftly engaged a team of third-party forensic experts to investigate. Following a full and thorough investigation, it was confirmed that three (3) employee email accounts were subject to unauthorized access during this incident. Upon confirmation of the unauthorized access to the employee email account, Martin immediately investigated whether the affected email accounts contained individuals' sensitive information. On June 1, 2021, after a thorough investigation, Martin determined that the unauthorized access may have allowed access to individual's personal information.

At this time, Martin is aware of four (4) residents of New Hampshire who may have been affected by this incident. As our investigation is ongoing, we will provide supplemental notification should we determine additional New Hampshire residents are potentially affected.

Martin will promptly notify the affected individuals on June 25, 2021, and offer the affected New Hampshire residents complimentary credit monitoring for twelve (12) months. A copy of the draft notification letter is attached, which outlines the incident and provides affected individual with additional resources to protect their identity and monitor the credit history and personal accounts. As the letter indicates, Martin will be offering credit monitoring and identity restoration services at Martin's expense. Martin is taking proactive steps to ensure that all state and federal notification obligations are complied with due to this incident.

**RE: NOTICE OF DATA BREACH**  
**Important Security Notification. Please read this entire letter.**

I am writing to inform you of a data security incident experienced by Martin Energy Group Services, LLC (“Martin”) that may have involved your personal information described below.

Martin takes the privacy and security of all information very seriously. While we have no evidence to suggest that any of the impacted information was viewed or misused during this incident, it is crucial that we be as supportive and transparent as possible. That is why I am writing to inform you of this incident, to offer information about steps that can be taken to help protect your information, and to let you know about complimentary identity monitoring services that we are offering you through Kroll.

I sincerely apologize for any concern that this incident may cause you. Let me reassure you that Martin is fully committed to supporting you.

**What Happened:**

On or about January 25, 2021, Martin fell victim to a phishing attack as a phishing email containing a malicious link was sent to several Martin employees. Upon discovery, Martin performed a password reset for the affected accounts and swiftly engaged a team of third-party forensic experts to investigate. Following a full and thorough investigation, it was confirmed that three (3) employee email accounts were subject to unauthorized access during this incident. Upon confirmation of the unauthorized access to the employee email accounts, Martin immediately investigated whether the affected email accounts contained individuals’ sensitive information. After a thorough investigation, Martin determined that the affected email inboxes contained limited personal information of individuals.

Although the forensic investigation could not rule out the possibility that an unknown third-party actor may have accessed certain email inboxes, there is no indication that any of your information stored within the accounts was actually viewed or has been misused in any manner. However, we are providing this notification to you out of an abundance of caution and so that you may diligently monitor your personal information and resources. We take great care in the security of our technology systems and regret that this incident has occurred.

**What Information Was Involved:**

It is important to note, as mentioned above, that there is no evidence to suggest that any of your personally identifiable information has been viewed or misused. We are simply notifying you that an email account which contained certain types of your personal information was subject to unauthorized access. The personal information that could have been accessed by the unauthorized individual(s) may have included your first and last name, in combination with your <<b2b\_text\_1(DataElements)>>.

**What We Are Doing:**

Martin has taken every step necessary to address the incident and is committed to fully protecting all of the information that you have entrusted to us. Unfortunately, network intrusions have become more common and this incident experienced by Martin is similar to experiences by other companies across a range of industries. Upon learning of this incident, we immediately secured the affected accounts, reset passwords, and took steps to enhance the security of all information to help prevent similar incidents from occurring in the future. We retained a third-party forensic firm to conduct a thorough investigation and are offering you complimentary identity monitoring services.

**Credit Monitoring:**

As a safeguard, we have arranged for you to activate, at no cost to you, in an online identity monitoring service for one year. Due to privacy laws, we cannot register you directly. Additional information regarding how to activate the complimentary identity monitoring service is enclosed.

**What You Can Do:**

In addition to activating in the complimentary identity monitoring service detailed within, we recommend that you remain vigilant in regularly reviewing and monitoring all of your account statements and credit history to guard against any unauthorized transactions or activity. If you discover any suspicious or unusual activity on any of your accounts, please promptly change your password and take additional steps to protect your account, and notify your financial institution or company if applicable. Additionally, please report any suspicious incidents to local law enforcement and/or your State Attorney General. We have provided additional information below, which contains more information about steps you can take to help protect yourself against fraud and identity theft.

## STEPS YOU CAN TAKE TO HELP PROTECT YOUR INFORMATION

### Activate Identity Monitoring Services

### Monitor Your Accounts

We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your credit reports/account statements for suspicious activity and to detect errors. Under U.S. law, you are entitled to one free credit report annually from each of the three major credit reporting bureaus, TransUnion, Experian, and Equifax. To order your free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call 1-877-322-8228. Once you receive your credit report, review it for discrepancies and identify any accounts you did not open or inquiries from creditors that you did not authorize. If you have questions or notice incorrect information, contact the credit reporting bureau.

You have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any of the three credit reporting bureaus listed below.

As an alternative to a fraud alert, you have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without your express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., III, etc.);
2. Social Security number;
3. Date of birth;
4. Address for the prior two to five years;
5. Proof of current address, such as a current utility or telephone bill;
6. A legible photocopy of a government-issued identification card (e.g., state driver’s license or identification card); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft, if you are a victim of identity theft.

You have been provided with access to the following services from Kroll:

### **Single Bureau Credit Monitoring**

You will receive alerts when there are changes to your credit data—for instance, when a new line of credit is applied for in your name. If you do not recognize the activity, you’ll have the option to call a Kroll fraud specialist, who will be able to help you determine if it is an indicator of identity theft.

### **Fraud Consultation**

You have unlimited access to consultation with a Kroll fraud specialist. Support includes showing you the most effective ways to protect your identity, explaining your rights and protections under the law, assistance with fraud alerts, and interpreting how personal information is accessed and used, including investigating suspicious activity that could be tied to an identity theft event.

### **Identity Theft Restoration**

If you become a victim of identity theft, an experienced Kroll licensed investigator will work on your behalf to resolve related issues. You will have access to a dedicated investigator who understands your issues and can do most of the work for you. Your investigator will be able to dig deep to uncover the scope of the identity theft, and then work to resolve it.

To receive credit services, you must be over the age of 18 and have established credit in the U.S., have a Social Security number in your name, and have a U.S. residential address associated with your credit file.
