Re: Data Security Incident

Dear Attorney General Foster:

We represent GEB Computer Training Limited d/b/a/ New Horizons Computer Learning Centers South Florida ("New Horizons"), a private corporation located in Plantation, FL with respect to a recent potential data security incident described in more detail below. New Horizons takes the security and privacy of the information in its control very seriously, and is taking steps to prevent a similar incident from occurring in the future.

**1. Nature of the security incident.**

On August 22, 2016, New Horizons discovered an unauthorized individual had gained access to its network. New Horizons immediately took action to secure its system and conducted an investigation to determine what information that individual may have gained access to. New Horizons determined that some files may have contained employee and student information, including names, addresses, Social Security numbers, and email addresses.

**2. Number of New Hampshire residents affected.**

One (1) New Hampshire resident was affected by the security incident. A Notification letter to this individual was mailed on October 6, 2016, by first class mail. A sample copy of the notification letter is included with this letter.

**3. Steps taken or plan to take relating to the incident.**

New Horizons is taking steps to prevent this incident from occurring again. This includes establishing more advanced internal security processes and procedures, hardening the network perimeter, and implementing additional security measures to ensure the protection of personal information.

New Horizons is also offering potentially impacted individuals credit monitoring and identity protection services, at no cost to the individual, through Kroll.


