Re: Security Breach Notification

Dear Attorney General Foster:

This letter is to provide you notice on behalf of Safe For Home Products LLC DBA Naturepedic of a recent security breach incident. On October 28, 2016, during an extensive scan, we learned that encrypted malware had been placed on our www.naturepedic.com website. Our staff promptly worked with the vendor who created our website to identify and remove the malware and to implement additional safeguards. We have reported the incident to law enforcement and are fully cooperating with their investigation.

The malware copied the information entered on our website to create online accounts and to place orders between June 6 and October 28, 2016, including a customer's name, address, telephone number, and credit card information. The investigation has not been able to determine whether the copied information was sent to the criminals. To our knowledge, the data accessed did not include any other personal information.

We are continuing to monitor the situation, and implement measures to further strengthen the security of its system to help prevent this from happening in the future.

To help protect the identity of the affected individuals, we are offering a complimentary one-year membership of Experian professional identity monitoring service. This service helps detect possible misuse of information, provides identity protection support, and up to \$1,000,000.00 in identity theft insurance.

Please find attached a copy of the notification that will be mailed to all 14 affected residents of your state beginning December 28, 2016.

We are writing to tell you about a data security incident that may have exposed some of your personal information. We take the protection and proper use of your information very seriously. For this reason, we are contacting you directly to explain the circumstances of the incident. Please be assured that we are taking reasonable steps to address the incident, and that we are committed to fully protecting all of the information that you have entrusted to us.

What happened?

On October 28, 2016, during an extensive scan, we learned that encrypted malware had been placed on our www.naturepedic.com website. Our staff promptly worked with the vendor who created our website to identify and remove the malware and to implement additional safeguards. We have reported the incident to law enforcement and are fully cooperating with their investigation.

What information was involved?

The malware copied the information entered on our website to create online accounts and to place orders between June 6 and October 28, 2016, including a customer's name, address, telephone number, and credit card information. The investigation has not been able to determine whether the copied information was sent to the criminals. To our knowledge, the data accessed did not include any other personal information.

What we are doing.

Naturepedic values your privacy and deeply regrets that this incident occurred. Naturepedic has implemented additional security measures intended to prevent a recurrence of such an attack, and to protect the privacy of Naturepedic's valued customers. As an initial matter, you will be asked to reset your www.naturepedic.com username and password.

To help relieve concerns and restore confidence following this incident, we have secured the services of Experian to provide a free PROTECTMYID membership for XX months which includes a credit report at signup, identity monitoring, active surveillance alerts, internet scan, address change alerts, fraud resolution, lost wallet protection, and \$1 million Identity Theft insurance at no cost to you.

Review Your Account Statements.

As a precautionary measure, we recommend that you remain vigilant for incidents of fraud and identity theft by reviewing your account statements and credit reports closely. If you detect any suspicious activity on an account, you should promptly notify the financial institution or company with which the account is maintained.

Free Credit Report. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting agencies.

To order your annual free credit report please visit www.annualcreditreport.com or call toll free at 1-877-322-8228.

You can also order your annual free credit report by mailing a completed Annual Credit Report Request Form (available from the U.S. Federal Trade Commission's ("FTC") website at www.consumer.ftc.gov) to: Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA 30348-5281.

For Colorado, Georgia, Maine, Maryland, Massachusetts, New Jersey, Puerto Rico, and Vermont residents: You may obtain one or more (depending on the state) additional copies of your credit report, free of charge. You must contact each of the credit reporting agencies directly to obtain such additional report(s).

Fraud Alert. You may place a fraud alert in your file by calling one of the three nationwide credit reporting agencies above. A fraud alert tells creditors to follow certain procedures, including contacting you before they open any new accounts or change your existing accounts. For that reason, placing a fraud alert can protect you, but also may delay you when you seek to obtain credit.

Security Freeze. You have the ability to place a security freeze on your credit report.

A security freeze is intended to prevent credit, loans and services from being approved in your name without your consent. To place a security freeze on your credit report, you may be able to use an online process, an automated telephone line, or a written request to any of the three credit reporting agencies listed above. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. The credit reporting agencies may charge a fee to place a freeze, temporarily lift it or permanently remove it. The fee is waived if you are a victim of identity theft and have submitted a valid investigative or law enforcement report or complaint relating to the identity theft incident to the credit reporting agencies. (You must review your state's requirement(s) and/or credit bureau requirement(s) for the specific document(s) to be submitted.)

For Massachusetts residents: The fee for each placement of a freeze, temporary lift of a freeze, or removal of a freeze is \$5.

Federal Trade Commission and State Attorneys General Offices. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your home state. You may also contact these agencies for information on how to prevent or avoid identity theft.

For Oregon residents: You are advised to report any suspected identity theft to law enforcement, the Federal Trade Commission, and the Oregon Attorney General.
