Re: Notice of Data Event

To Whom It May Concern:

We represent Science Systems and Applications, Inc. (“SSAI”), located at 10210 Greenbelt Road #600, Lanham, MD 20706, and are writing to notify your office of an incident that may affect the security of certain personal information relating to approximately three (3) New Hampshire residents. The investigation into this matter has concluded. By providing this notice, SSAI does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

Nature of the Data Event

On or around January 3, 2024, SSAI identified suspicious activity within its systems. With the assistance of third-party cyber security specialists, SSAI immediately launched an investigation into the nature and scope of the event. Through the investigation, SSAI learned there was unauthorized access to SSAI’s systems at various times from January 1, 2024 to January 3, 2024. On or about January 31, 2024, the investigation determined that the unauthorized actor had access to certain files and folders within SSAI’s system which contained personal information.

The information that could have been subject to unauthorized access includes

Notice to New Hampshire Residents

On February 9, 2024, SSAI provided written notice of this incident to approximately three (3) New Hampshire residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, SSAI moved quickly to investigate and respond to the incident, assess the security of SSAI systems, and identify potentially affected individuals. Further, SSAI notified federal law enforcement regarding the event. SSAI is also working to implement additional safeguards and training to its employees. SSAI is providing access to credit monitoring services for _____, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, SSAI is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. SSAI is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

SSAI is providing written notice of this incident to relevant state regulators, as necessary.

NOTICE OF [Extra1]

Dear Sample A. Sample:

Science Systems and Applications, Inc. (hereinafter “SSAI”) writing to inform you of a recent IT security incident that may affect the security of some of your information. Although we have no indication that your information has been fraudulently misused in relation to this event, we are providing you with information about the event, our response, and additional measures you can take to help protect your information, should you feel it appropriate to do so.

What Happened? On or around January 3, 2024, SSAI identified suspicious activity within its systems. With the assistance of third-party cyber security specialists, we immediately launched an investigation into the nature and scope of the event. Through the investigation, we learned there was unauthorized access to SSAI’s systems at various times from January 1, 2024 to January 3, 2024. The investigation determined that the unauthorized actor had access to certain files and folders within our system.

In an abundance of caution, we completed a comprehensive review of the potentially impacted information and to whom it related. This review has recently been completed.

What Information Was Involved? Our investigation determined that your W-2 information was present in the potentially impacted files at the time of the event. This information includes your

What We Are Doing. We at SSAI take this event and the security of information in our care seriously. Upon discovering this event, we promptly took steps to investigate and respond to the incident, assess the security of our systems, restore functionality to our environment, and notify potentially affected individuals. As part of our ongoing commitment to the privacy of personal information in our care we are working to review our existing policies and procedures and to implement additional administrative and technical safeguards to further secure the information on our systems.

While we are unaware of any fraudulent misuse of your information as a result of this event, as an additional precaution, SSAI is offering you access to [Extra2] months of complimentary credit monitoring and identity restoration services through Experian. Details of this offer and instructions on how to activate these services are enclosed with this letter.

What You Can Do. As a precautionary measure, we encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. Additional resources can be found below in the *Steps You Can Take to Help Protect Personal Information*, which contains information on what you can do to better protect against possible misuse of your information. You may also enroll in the complimentary credit monitoring services being offered.

Enroll in Monitoring Services

To help protect your identity, we are offering complimentary access to Experian IdentityWorksSM for [Extra2] months.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. The Federal Trade Commission may be reached at: 600 Pennsylvania Avenue NW, Washington, D.C. 20580; www.identitytheft.gov; 1-877-ID-THEFT (1-877-438-4338); and TTY: 1-866-653-4261. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. Consumers have the right to file a police report if they ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and the relevant state Attorney General. This notice has not been delayed by law enforcement.

Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to consumers' files is limited; consumers must give consent for credit reports to be provided to employers; consumers may limit "prescreened" offers of credit and insurance based on information in their credit report; and consumers may seek damages from violators. Consumers may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
