Re: Notice of Data Event

Dear Sir or Madam:

We represent Simms Fishing Products, LLC (“Simms Fishing”) located at 177 Garden Drive, Bozeman, MT 59718, and are writing to notify your office of an incident that may affect the security of some personal information relating to nine (9) New Hampshire residents. The investigation into this matter is ongoing, and this notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Simms Fishing does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

Nature of the Data Event

On November 24, 2020, Simms Fishing became aware of suspicious activity on its e-commerce website, www.simmsfishing.com. Upon discovery, Simms Fishing neutralized the threat to prevent any future harm. Immediately thereafter, Simms Fishing began working with third-party computer forensic specialists to determine what happened and what information may have been affected. Simms Fishing also took steps to implement additional procedures to further protect the security of customer debit and credit card information on its website. Customers can safely and securely use their payment card on the website.

On January 8, 2021, the investigation determined that Simms Fishing was the victim a cyber-attack that may have resulted in a compromise of some of customers’ payment cards used to make purchases on its e-commerce website between October 29, 2020 and November 24, 2020. Once the investigation confirmed the dates of compromise, Simms Fishing took steps to identify and

notify potentially impacted customers who made purchases during this time period. This process completed on January 14, 2021 and Simms Fishing moved quickly to notify impacted individuals.

The information impacted includes the cardholder's name, address, credit card number, expiration date, and CVV.

Notice to New Hampshire Residents

On February 5, 2021, Simms Fishing began providing written notice of this incident to potentially affected individuals, which includes nine (9) New Hampshire residents. Written notice is being provided in substantially the same form as the letter attached hereto as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, Simms Fishing moved quickly to investigate and respond to the incident, assess the security of Simms Fishing systems, and notify potentially affected individuals. Simms Fishing also reviewed their existing policies and procedures and implemented additional safeguards to further secure the information in its systems.

Additionally, Simms Fishing is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. Simms Fishing is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, information on protecting against tax fraud, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Simms Fishing Products LLC (“Simms Fishing”) is writing to notify you of an incident that may affect the security of your payment card information. Simms Fishing takes this incident very seriously and is providing you with details about the incident, our response, and steps you can take to better protect your payment card information, should you feel it appropriate to do so.

What Happened? On November 24, 2020, Simms Fishing became aware of suspicious activity on its e-commerce website, www.simmsfishing.com. Upon discovery, Simms Fishing neutralized the threat to prevent any future harm. Immediately thereafter, Simms Fishing began working with third-party computer forensic specialists to determine what happened and what information may have been affected. Simms Fishing also took steps to implement additional procedures to further protect the security of customer debit and credit card information on our website. You can safely and securely use your payment card on our website.

On January 8, 2021, the investigation determined that Simms Fishing was the victim a cyber-attack that may have resulted in a compromise of some of our customers’ payment cards used to make purchases on our e-commerce website between October 29, 2020 and November 24, 2020. Once the investigation confirmed the dates of compromise, Simms Fishing took steps to identify and notify potentially impacted customers who made purchases during this time period. This process completed on January 14, 2021 and Simms Fishing moved quickly to notify impacted individuals.

What Information Was Involved? Through the third-party forensic investigation, we confirmed that malware may have stolen credit or debit card data from some credit and debit cards used on our website, www.simmsfishing.com, between October 29, 2020 and November 24, 2020. The information at risk as a result of the event includes the cardholder’s name, address, credit card number, expiration date, and CVV.

What Simms Fishing is Doing. Simms Fishing takes the security of your personal information seriously. We immediately began working with a third-party computer forensic investigation firm and took steps to ensure that payment card transactions were secure. We are also working to improve security protocols already in place to continue to protect against potential unauthorized activity. Simms Fishing also notified the major payment card brands and its card processor of the incident and the steps taken to return to processing payment card transactions securely. Simms Fishing also notified state regulators, as required.

What You Can Do. We encourage you to remain vigilant for instances of fraudulent charges or misuse by monitoring your accounts and reviewing the enclosed *Steps You Can Take to Help Protect Personal Information* for additional guidance on how to protect against payment card fraud from any source.

Steps You Can Take to Help Protect Personal Information

Monitor Your Accounts

We encourage you to remain vigilant against incidents of payment card fraud or misuse, to review your account statements, and to monitor your credit reports for suspicious activity. If you see any unauthorized or suspicious activity, promptly contact your bank, credit union, or credit card company.

Under U.S. law you are entitled to one free credit report annually from each of the three major credit reporting bureaus. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also contact the three major credit bureaus directly to request a free copy of your credit report.

Place a Security Freeze

You have the right to place a “security freeze” on your credit report, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization. The security freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a security freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a security freeze on your credit report. In order to request a security freeze, you will need to provide the following information:

1. Your full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. If you have moved in the past five (5) years, provide the addresses where you have lived over the prior five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver's license or ID card, military identification, etc.);
7. If you are a victim of identity theft, include a copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft.

Place a Fraud Alert

As an alternative to a security freeze, you have the right to place an initial or extended “fraud alert” on your file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years.
