Re: Incident Notification

Dear Attorney General MacDonald:

We are writing on behalf of our client, Twin Farms Holdings, LLC (“Twin Farms”), to notify you of a security incident involving six New Hampshire residents.

Twin Farms recently concluded its investigation of a security incident involving unauthorized access to an employee’s email account. Upon learning of the incident, Twin Farms immediately took steps to secure the email account and launched an investigation with the assistance of an IT security firm. Through the investigation, Twin Farms learned that an unauthorized party obtained access to the employee’s email account at various times between March 26, 2020 and June 8, 2020. The investigation was unable to determine what emails or attachments, if any, were viewed by the unauthorized person. Out of an abundance of caution, Twin Farms conducted a comprehensive review of the emails and attachments in the account to identify individuals whose information may have been accessible to the unauthorized. Through this review, Twin Farms determined the names, Social Security numbers, and/or drivers’ license numbers of six New Hampshire residents were contained in the email account.

On October 30, 2020, Twin Farms began mailing notification letters to the New Hampshire residents pursuant to N.H. Rev. Stat. § 359-C:20(c),¹ in substantially the same form as the enclosed letter. Twin Farms is offering the individuals a complimentary one-year membership to credit monitoring and identity theft protection services. Twin Farms has also established a dedicated,

toll-free call center where all individuals may obtain more information regarding the incident.

To help prevent something like this from happening in the future, Twin Farms is reinforcing education with staff regarding how to identify and avoid suspicious emails and is making additional security enhancements to its email environment.

At Twin Farms, we place a high value on maintaining the integrity and security of the data we hold. Regrettably, we are writing to inform you that we recently identified and addressed a security incident that may have involved some of your information. This notice describes the incident, outlines the measures we have taken in response, and provides steps you can take.

We recently concluded our investigation of a security incident involving unauthorized access to an employee's email account. Upon learning of the incident, we immediately took steps to secure the email account and launched an investigation with the assistance of an IT security firm. Through the investigation, we learned that an unauthorized party obtained access to the employee's email account at various times between March 26, 2020 and June 8, 2020. The investigation was unable to determine what emails or attachments, if any, were viewed by the unauthorized person. As part of our investigation, we conducted a comprehensive review of the emails and attachments in the account to identify individuals whose information may have been accessible to the unauthorized person. Through this review, we identified emails or attachments that may have contained your name and Social Security number.

We have no indication that your information was actually viewed by the unauthorized person, or that it has been misused. However, we wanted to let you know that this incident occurred and assure you that we take it very seriously. As a precaution, we are offering you a complimentary one-year membership of Experian IdentityWorksSM Credit 3B. This product helps detect possible misuse of your personal information and provides you with superior identity protection support focused on immediate identification and resolution of identity theft. IdentityWorksSM Credit 3B is completely free to you. Enrolling in this program will not hurt your credit score. For more information on identity theft prevention and instructions on how to activate your complimentary one-year membership, please see the additional information provided in this letter.

We regret any inconvenience or concern this incident may cause. To help prevent something like this from happening again, we are enhancing our email security and providing continued education to our staff on email protection. We remind you it is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Fraud Alerts and Credit or Security Freezes:

Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. For information and instructions to place a security freeze, contact each of the credit reporting agencies at the addresses below:

You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.
