To whom it may concern,

In accordance with New Hampshire RSA 359, the purpose of this email is to serve as notification of a Data Security Breach involving our client, Walpole Outdoors LLC that may have affected 4 residents of New Hampshire.

Walpole Outdoors discovered that on January 6, 2021, it was the target of an electronic mail phishing attack. Only one user account was accessed in the attack.

After completion of our extensive investigation, which was finalized on April 7, 2021, we have determined that some personal information of these 4 people was contained within one or more emails in the account. Walpole Outdoors possesses this information because it relates to employee benefits. The employee whose account was hacked works with employee benefits, which is why the email account contained this information.

Based upon the nature of the attack, we believed that the goal of the attack was to elicit payment of funds from Walpole Outdoors. As part of the scheme, the perpetrator(s) provided Walpole Outdoors with a fraudulent invoice. Therefore, we do not believe the perpetrator(s) sought personal information.

In sum, we have no evidence to indicate that the perpetrator(s) viewed or copied the information of these 4 residents of New Hampshire. To be safe, we are issuing notices in accordance with New Hampshire RSA 359: C-20 to these 4 people this week to notify them of this incident and to provide them with some suggested response actions that they may wish to take as a precaution.
