What is the goal of RSAT?

- Federal funding from the US DOJ Bureau of Justice Assistance
- Support states and local governments in their efforts to:
 - a) *Reduce the demand and use of illegal substances*
 - b) *Reduce trafficking of illegal drugs*
 - c) *Increase access to evidence-based treatment and recovery support services*
 - d) *Reduce recidivism rates*
 - e) *Reduce overdose deaths*

Who is eligible to apply for funding?

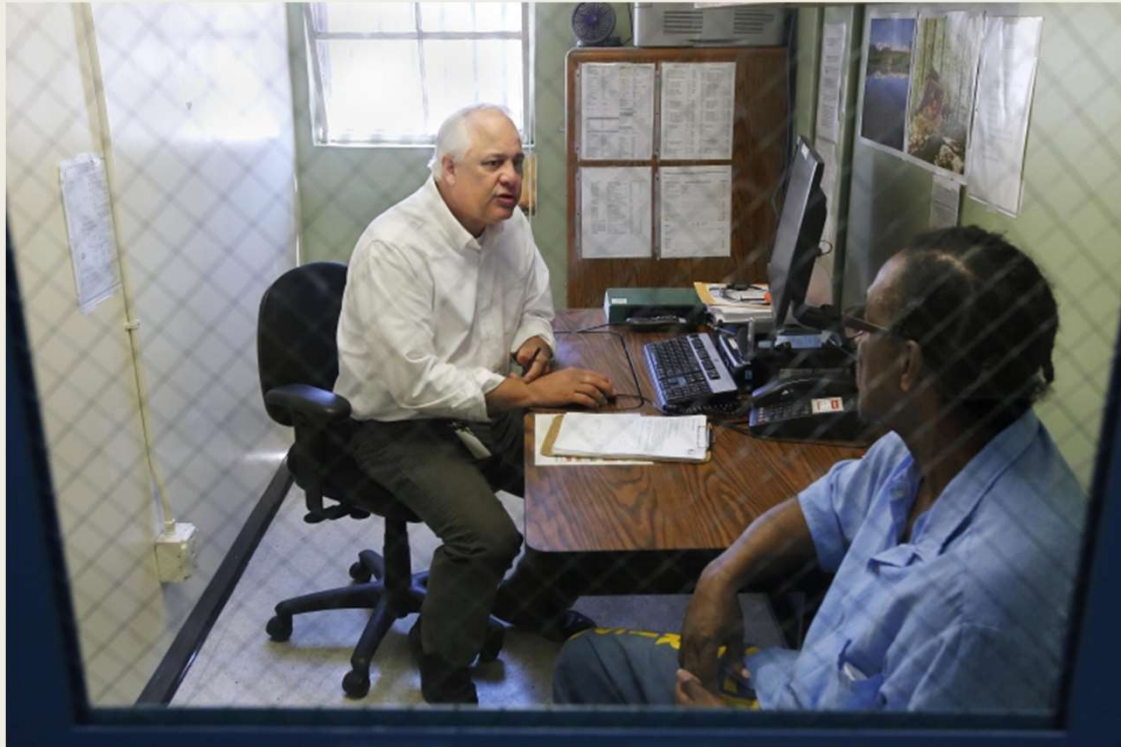
- The New Hampshire Department of Corrections
- County Corrections or their governing bodies
- Youth Detention Centers

3 types of allowable programs

RESIDENTIAL

JAIL-BASED

AFTERCARE



Residential

- 6 months or longer
- Prison or jail-based
- Incarcerated
- Provides aftercare services/coordination
- Variety of evidence-based programming options
- Must be separated from general population

Jail-based

- 6 Months or longer
- Under 6 months
- Incarcerated awaiting trial/sentencing
- Sentenced
- Varsity evidence-based programming options
- Requires aftercare programming/coordination



Aftercare

- Transitional Housing support
- Community based-treatment
- Recovery Services
- Other broad-based aftercare services (Evidence-based)
- Prepare for reintegration



Requirements of RSAT subgrantees



- Participants must have access and coordinated support for aftercare services (Institutional or community-based)
- Random urinalyses
- Evidence-based Treatment/programming/practices
- MAT availability for those that qualify
- Collection/sharing data and progress
- PMT (Performance Measurement Tool)
- Be willing to work with RSAT technical support providers contracted by BJA
- Comply with Federal Financial Guidelines

Recent Changes to RSAT

- New Category “Nonresidential” programming (Not eligible for Prisons)
- May use RSAT funding to support those that have not been sentenced
- RSAT supported MAT Treatment/support services for individuals that will be in correctional facilities under 90 days (must have a complete and achievable aftercare plan)
- Jail-based programming under 6 months long are not required to separate from general population

Potential Programming Ideas

- Substance abuse treatment
- Case Management/Re-entry Services
- Medical Assistant Treatment (MAT)
- Telehealth services and equipment
- Peer support for drug treatment participants
- Motivational therapy, cognitive behavioral therapy
- Moral Reconciliation Therapy (MRT)
- Advanced training for Staff (does not include college tuition assistance)
- Couples/Family Therapy for Drug Treatment participants
- Employment support services for drug treatment participants
- Aftercare services
- Justifiable outsourcing of essential support Services
- Trauma Informed training for Staff
