

Timeline of Terry Peder RASMUSSEN and Marlyse Elizabeth HONEYCHURCH

| 1943 December 23 | Born in Colorado named Terry Peder RASMUSSEN . |
| 1954 January 28 | Born in Connecticut named Marlyse Elizabeth HONEYCHURCH |
| 1954 - 1958 | RASMUSSEN attended Whittier Elementary School, Phoenix, AZ. |
| 1958 July - 1961 April | RASMUSSEN resided in Phoenix with Family |
| 1959 - 1960 | RASMUSSEN attended North High School, Phoenix, AZ. RASMUSSEN dropped-out after sophomore year. |
| 1961 April | RASMUSSEN enlisted in the US Navy. |
| 1967 July | RASMUSSEN discharged from the US Navy. |
| 1967 - 1968 | RASMUSSEN moved to Hawaii and worked in his parents' shoe shop. |
| 1968 July 20 | RASMUSSEN married wife in Hawaii. |
| 1969 | RASMUSSEN moved to Phoenix, AZ. Twin daughters born. Worked as an electrician for a boss named "Otto" (company unknown). |
| 1969 | MARLYSE is a sophomore at Stamford High School, Stamford, CT. MARLYSE moved from Connecticut to California at 15 years old. |
| 1970 | MARLYSE is a sophomore at Artesia High School, Lakewood, CA. MARLYSE is now using her mother's last name of SALAMON and believed to be living with her mother in La Mirada, CA. MARLYSE developed a relationship with a boyfriend. |
| 1970 | RASMUSSEN family moved to Redwood City, CA. RASMUSSEN worked as an Electrician in Palo Alto, CA. RASMUSSEN's son is born. |
| 1971 June 12 | MARLYSE married husband in Las Vegas, NV. |
| 1971 – 1972 | MARLYSE lived in various locations in California. |
| 1971 December 6 | Birth of MARLYSE's daughter, Marie E. VAUGHN . |

1972 RASMUSSEN's daughter is born.
RASMUSSEN and his wife temporarily separate.

1972 February MARYLSE and family are living in Los Angeles, CA.

1972 June MARYLSE and family moved to Stamford, CT and lived with MARLYSE's father.

1973 approx. RASMUSSEN and family move back to Phoenix.
RASMUSSEN again works for "Otto." He also works in a shoe shop.

1973 February/March MARYLSE and family moved to Fall River, MA.

1973 April RASMUSSEN arrested by Maricopa County Sheriff's Office

1973 July MARLYSE's husband and daughter, MARIE move to Lakewood, CA.
MARLYSE's whereabouts are unknown.

1973 Summer MARLYSE traveled to Lakewood, CA and took custody of MARIE, when MARIE's father was not present.

1974 February MARIE's father divorces MARLYSE.
MARLYSE is awarded custody of MARIE.

1974 September MARLYSE marries her second husband in Los Angeles, CA.

1975 February MARLYSE and MARIE are believed to be living in Downey, CA.

1975 May MARLYSE and MARIE are believed to be living on Camp Pendleton base in San Diego County, CA.

1975 June RASMUSSEN is arrested in Phoenix, Arizona for aggravated assault.
It is believed that his wife and children left him shortly after this arrest.

1975 or 1976, December RASMUSSEN arrives unexpectedly to visit his wife and children in Payson, AZ. **He is in the company of an unidentified female.**
RASMUSSEN indicates he was living at the Casa Del Rey Apartments in Ingleside, TX. This is the last time RASMUSSEN is seen by his family.

1976 January MARLYSE and MARIE are believed to be living in Santa Ana, CA.

1976 March 30 MARIE is brought to the base clinic because she has scarlet fever.

1976 August MARIE's father notes his last contact with MARLYSE and MARIE was in Hawaiian Gardens, CA.

1977 December 13 Birth of MARLYSE's second daughter **Sarah L. MCWATERS**.

1978 June RASMUSSEN works for the "Brown & Root" Company in Houston, TX. Record indicates RASMUSSEN "quit to work elsewhere."

1978 RASMUSSEN contacts friend in Arizona and asks for money. He states he is in Texas working on an oilrig.

1978 MARLYSE and SARAH's father separate.

1978 August 30 SARAH's father was awarded temporary custody of SARAH. MARLYSE was awarded reasonable visitation rights.

1978 September 28 RASMUSSEN's divorce is finalized. RASMUSSEN's whereabouts unknown.

1978 October SARAH's father meets and develops a relationship with a new woman. SARAH is not observed and is presumably with MARLYSE.

1978 November MARLYSE was last seen by her family on Thanksgiving at her mother's house in La Puente, CA.

MARLYSE introduced the family to Terry RASMUSSEN. This is the 1st and only time MARLYSE's family had contact with RASMUSSEN. **MARLYSE's family believes she left with RASMUSSEN and her two daughters.** **RASMUSSEN did not bring any children with him to La Puente, CA.**

1978 or 1979 December A photo suggests Marie VAUGHN may have celebrated her 7th or 8th birthday with relatives in an unknown location.

1978 - 1979 (approx.) RASMUSSEN worked at Waumbec Mills in Manchester, NH as head electrician. He is now known as Bob Evans.

1980 January **Elizabeth Evans** signed a certified letter in Manchester, NH. RASMUSSEN is associated with the same address.

1980 February RASMUSSEN arrested in Manchester, NH as Robert T. Evans for Issuing a bad check on 12/21/1979 (insufficient funds).

- Wife is listed as **Elizabeth**.

1980 May Robert T. Evans arrested in Manchester, NH for theft of services (electricity).

- Spouse is listed as **Elizabeth**.

| 1981 November | Denise Beaudin of Manchester, NH goes missing shortly after Thanksgiving with her 6-month-old daughter and her boyfriend, Robert T. Evans (Terry Rasmussen). |
| 1984 March - 1985 May | RASMUSSEN was hired under name Curtis Kimball by electrical company in Los Alamitos, CA. |
| 1985 May | RASMUSSEN arrested in Cypress, CA as Curtis Mayo Kimball for DUI. |
| 1985 November | First barrel found adjacent to Bear Brook State Park, Allenstown, NH containing an unidentified adult female (23-33 yoa) and female child (5-11 yoa). |
| 1986 January | RASMUSSEN in Santa Cruz County, CA living & working at the Holiday Host RV Park in Scotts Valley under name Gordon Jenson. |
| 1986 June | RASMUSSEN abandoned a child (Denise Beaudin's daughter) in California and fled. |
| 1986 September | Fingerprints match between Gordon Jenson and Curtis Mayo Kimball confirming they were the same person. |
| 1988 November | RASMUSSEN pulled over in San Luis Obispo, CA under the name Gerry Mockerman, driving a stolen vehicle from Preston, Idaho. |
| 1989 March | RASMUSSEN arrested in California on warrants for child abandonment and sentenced to 3 years. |
| 1990 October | RASMUSSEN was paroled and absconded the following day in California. |
| 1998 June | RASMUSSEN stopped in California under the name Lawrence William Vanner and cited for not having insurance or a driver's license. |
| 2000 May | Second barrel found adjacent to Bear Brook State Park in Allenstown, NH containing two unidentified female children (2-4 yoa) and (1-3 yoa). The 2-4 yoa child was later determined to be RASMUSSEN'S biological child. |
| 2002 June | RASMUSSEN's girlfriend, Eunsoon Jun disappears from Richmond, CA. |

2002 November RASMUSSEN arrested for Eunsoon Jun’s murder and parole violation.

2003 June RASMUSSEN convicted of Eunsoon Jun’s murder and sentenced to prison for 15 years to life.

2003 August DNA testing confirmed that the RASMUSSEN was not the biological father of the child he abandoned in June 1986 (Denise Beaudin’s daughter).

2010 December RASMUSSEN died in prison.

2016 July The California San Bernardino County Sheriff’s Office contacted New Hampshire authorities reference RASMUSSEN and his connection to New Hampshire.

2016 October DNA confirmed that RASMUSSEN was the biological father of the unidentified 2-4 year old little girl found dead in Allenstown, NH in 2000.

2017 January Authorities release details of subject Robert “Bob” Evans and his connection to the Allenstown homicides and disappearance of Denise Beaudin.

2017 July Authorities complete DNA testing confirming the man known as Robert “Bob” Evans is actually Terry Peder RASMUSSEN.

2019 June Authorities announce that three of the four Allenstown victims have been identified as Marlyse Honeychurch, Marie Vaugh, and Sarah McWaters.
