Subj: 6-month compliance tour per RSA 30-B:12

Due to Covid precautions to restrict traffic within the facility, the tour was completed by Lieutenant Lockhart and Captain Brookens on November 22, 2021, on behalf of the Superintendent and the Board of Commissioners. The tour began at 1300 and ended at 1410.

The tour began on the bridge of the Community Corrections Center with the following being noted.

- 1. Wood stanchion pole bumper should be removed and refinished, this would be a good winter job.
- 2. Emergency lights exterior door 201B not working
- 3. Emergency lights outside elevator not working
- 4. Outside door 101A electrical conduit has deteriorated and needs replacement
- 5. We will be looking to replace storage cabinets CCC dining area next year

All areas of the Community Corrections Center were inspected, and work orders completed for minor repairs to be done.

The tour continued at the Jail with the following items being noted.

- 1. Unit 3 door 300 needs to have old lockbox removed
- 2. Sprinkler heads located in the inmate visiting side need to have tamper covers put over them
- 3. Emergency lights located at the Sally port not working
- 4. Emergency light in the Jail Nurses office not working

All areas of the Jail were inspected, and work orders completed for minor repairs to be done

General comments; while walking the entire Corrections complex it is very apparent the entire ventilations system is in need of cleaning; it can be seen at almost every vent cover. Also, it will need to be addressed to correctly have an AC system capable of cooling the electrical room located in the basement of the jail.
