Hello New Hampshire,

This letter is similar but different to other ones which you may have received lately, as such please review it carefully.

Pursuant to the Right to Know Law (RSA. 91-A), I am requesting public access, within 5 business days (on or before June 17, 2021), to the governmental records reasonably described as follows:

- 1. I request a detailed timeline of exactly any and all involvement of Harri Hursti and Nordic Innovation Labs regarding New Hampshire's Accuvote machines and all other elections related equipment. Please also send all written, email and text message communications between the Secretary of State's office and the AG's office involved with Harri Hursti and Nordic Innovation Labs. Please send a thorough detailed timeline of any involvement of Mr. Hursti and our Accuvote machines. I am requesting information dated 2009 through 2021. This is to include any contracts, payments, and services rendered by Mr. Hursti
- 2. In 2016, James O'Keefe was served a subpoena from Richard (Dick) Tracy. Pursuant to article 91A, I request any and all the information James O'Keefe supplied to the NH's AG office as well as the NH Secretary of State's office for this subpoena.
- 3. I request any and all invoices paid to LHS Associates, Inc by the State of NH for the last 7 years as well as a copy of any and all contracts that the state has with LHS Associates, Inc. for the same time period.
- 4. In 2010 all NH machines received a "firmware update." Please send any and all information pertaining to this update. Also include the names of the personnel who performed the updates.
- 5. There are five towns whose town clerks state either the SOS has their machine tapes from the 2020 election or they are locked in their ballot boxes. Bud Fitch recently sent an email to a concerned citizen where he stated that the citizen would have to go through the court process to receive this public information. This does not sound logical knowing that any judge would obviously grant a citizen access to this PUBLIC INFORMATION; it should not require a citizen to seek counsel to obtain public information. I'm hoping we can receive this information lawfully without wasting hard earned tax paying money. The five towns are as follows:
 - A. Hollis
 - B. New Ipswich
 - C. Rindge
 - D. Westmoreland
 - E. Wilton
 - F. Milford
- 6. According to Harri Hursti, the reason why he is not being supervised while continuing the audit is due to copyright infringements. Please provide details on who released those copyrights to Harri. Who has the exclusive access to these copyrights? What the process is for me to receive released copyrights as well.
- 7. I request any non-disclosure agreements between Harri Hursti as well as Nordic Innovation Labs and the State of New Hampshire and its affiliates and Diebold Premier.
- 8. Who printed New Hampshire's Ballots for the 2020 general election that took place on November 3, 2020? Please list whether hand counting towns (including NH State Prison) ballots are printed independently from machine ballot towns. Please also list whether absentee ballots are printed independently of walk-in ballots. Please list any and all companies that are involved in any way with processing our ballots (designing, printing, folding, handling, delivering, etc) from the inception of the ballot up until it reaches the towns.
- 9. Please provide the most current manual(s) for the NH Accuvote machines.
- 10. Logs of chain of custody for Windham's machines memory cards as well as the chain of custody records for the town of Windham ballots.
- 11. A copy of the "exact electronic record of the data written to each memory card" used in Windham for the November 3, 2020 election per RSA 656:42 VIII. (a) -

Before each election, the vendor for any electronic ballot counting device shall provide the secretary of state with an exact electronic record of the data written to each memory card to be used in the election.

12. I request the digital image files (PDF/JPG) of the original printed ballots (i.e. NOT scanned ballots or photocopies) for every style of ballot printed in the 2020 general election.

- 13. A list of all of the election races for the 2020 General Election on November 3,2020 with details for each race to include 1.) the precinct or town for that race and 2.) the list of candidates for that race.
- 14. A list of every Accuvote voting machine owned by the state with details to include: serial number, date of purchase, installed software/firmware version, date of last software/firmware upgrade, date of last maintenance, date of last calibration, name of technician who performed the last calibration, status of the machine from June 2020 December 2020, and the town (and/or precinct) that the machine was located during the General election held on november 3, 2020.

Per RSA 91-A:4 IV(c) If you deny any portion of this request, please cite the specific exemption used to justify the denial to make each record, or part thereof, available for inspection along with a brief explanation of how the exemption applies to the information withheld. Pursuant to RSA 91.1; these records are being requested to be received within 5 business days (on or before June 17, 2021) to be made available for inspection.
